 4. At _____ we treat each other with respect, so it is forbidden to express insults or making discriminatory comments towards guests and staff.
 5. As from 13 December 2014 we must deal with a law according to allergens, the protocol related to this will only apply if you indicated to our personnel that you have a food allergy / intolerance.
 6. At _____ we treat each other with respect, so it is forbidden to sexual intimidate by word or by gestures (acts) any of our guests and / or employees.
 7. At _____ you need to comply with the demands of the Licensing- and Catering Act from 1 January 2014, high- and low alcohol beverages will not be provided to guests under 18 years of age. When in doubt about the guest's age, employees of _____ will ask for a valid identification. This also applies for the Tobacco Act.
 8. In case of suspicion of drunkenness there will not be served more alcohol to this person, in order to not have the atmosphere negative influenced during your stay.
 9. During your stay, you make use of the properties of _____ and third parties, it is forbidden to steal and/or damage any of these. This will be declared as a crime.
 10. To monitor peace, order and safety within _____, it is forbidden to use violence or to threat with violence to any of the guests or personnel.
 11. To offer you and your family, friends and acquaintances a pleasant stay, it is forbidden to possess, use or trade drugs or weapons.
 12. _____ does not offer their location for other purposes than mentioned in our policy, for that reason it is forbidden to trade or fence any goods.
 13. The employees of _____ take care of your safety, in case of a calamity the emergency plan will be applied. You are politely but firmly asked to chase down the leads of the employees or the safety officers.
 14. Do not leave your personal belonging at the location of _____ without supervision and neither in your car. _____ is not responsible for loss, theft, or damaged personal belongings. Parking, both as on the parking as in the area of _____, is at your own risk.
 15. We take care of our and your belongings with visible and invisible camera's, the tapes are always for exchange with justice.
 16. When entering _____ you agree to the house rules and the applicable Legal Enforcement Policy.
